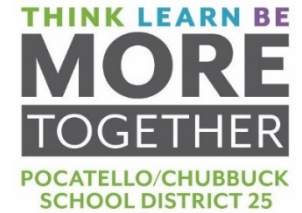


# PCSD 25 Roadmap for the Safe Return to In-Person Instruction and Continuity of Services for the 2021-2022 School Year

- We will provide our staff, learners and families with the support, training and tools needed to adapt to an ever-evolving educational environment.
- We will be transparent, timely and accurate in all communications.
- In pivoting to respond to the unpredictable future, we will remain firmly grounded in our District mission, vision and beliefs.

## LEADERSHIP DASHBOARD: Key Metrics for Decision Making

PCSD 25 operational decisions will be based upon an in-depth review of the key metrics provided by the Leadership Dashboard to develop recommendations to advise the Board of Trustees. The district leadership team works in partnership with school administrators, Southeastern Idaho Public Health and local medical providers, as well as state and local governing agencies. The team determines, based on the key metrics listed below, any recommendations to the Board for action to revise or add mitigation strategies to the current Roadmap. Revisions or additions to mitigation strategies may include, but are not limited to, the use of masks, physical distancing/cohorting in the classroom, increased sanitizing protocols, changes in schedules to limit class size, or shifts to remote instruction for a limited time. Data will be routinely monitored by the leadership team, to prioritize face-to-face learning, in-person, five days a week.

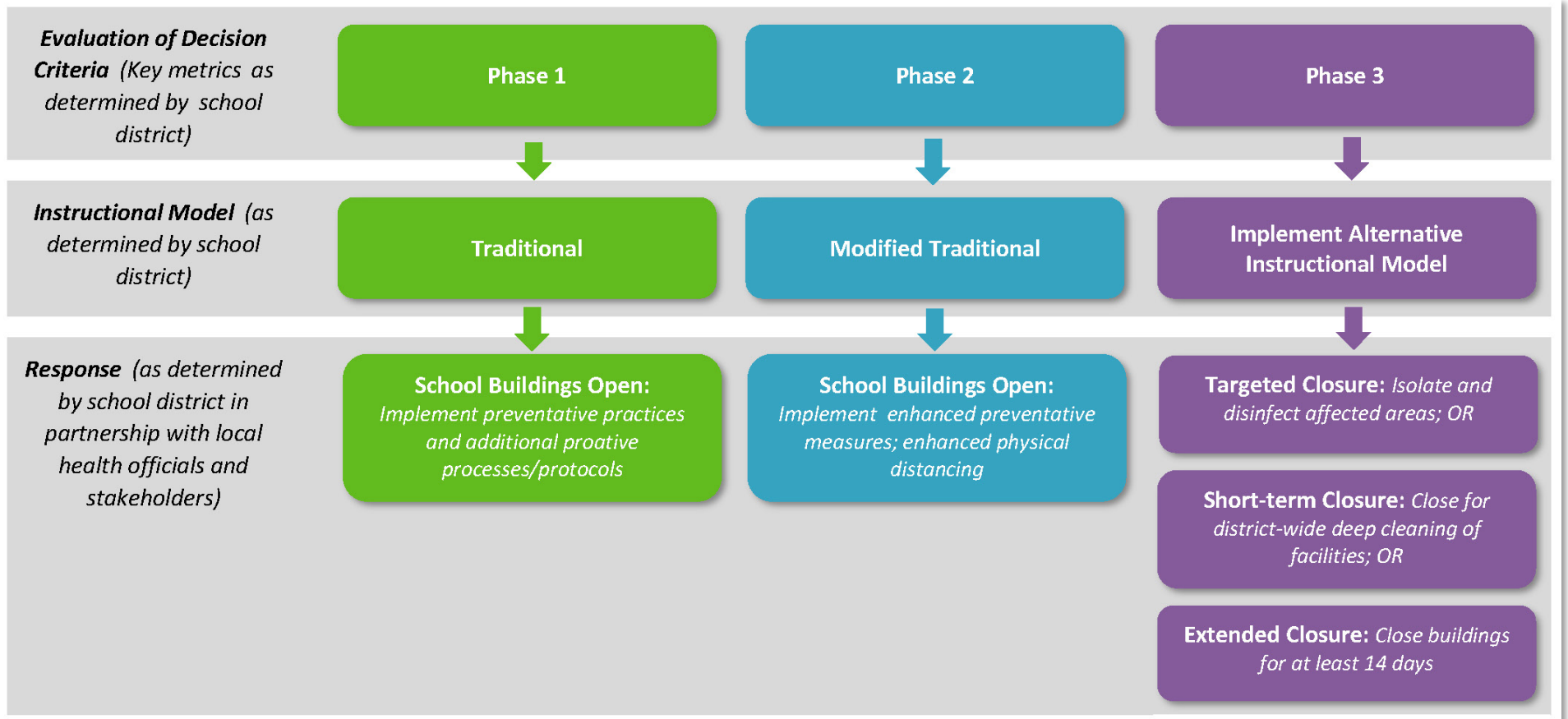
The following criteria may be applied to a group(s), a school(s), or district wide:

- Overall impact of virus on community: Using CDC's COVID-19 data tracker and other relevant data, including local/regional hospital capacity and implementation of crisis standards of care.
- Rate of active cases in Bannock County sustained for 14 days (data provided by SIPH).
- Number of positive cases: Learners and staff.
- Impact on learners: Quarantines due to COVID-19 and overall learner absences.
- Impact on staff: Quarantines due to COVID-19 and overall staff absences.
- Partner recommendations: State and local governing agencies, health and medical providers.
- Monitoring trends: Includes district, school or cluster outbreak(s).

Information will be provided to staff, learners and families on proper use, removal and washing of cloth masks. (See <a href="#">CDC How To Wear Masks</a>) Face coverings are recommended, but are optional, however, the Board may require face masks/coverings at any time if widespread and rapid community and/or school transmission occurs.</p>	<p style="text-align: center; font-weight: bold;">Hand Sanitizer/Hand Washing</p> <div style="text-align: center;">  </div> <p>Hand sanitizer should contain at least 60% alcohol. Learners and staff are encouraged to use soap and water when available taking care to wash their hands for at least 20 seconds.</p>	<p style="text-align: center; font-weight: bold;">Clean/Disinfect</p> <div style="text-align: center;">  </div> <p>Disinfecting products will be EPA-approved. Staff will ensure the safe and correct application of disinfectants and are responsible to keep them locked in a secure area when not in use.</p>	<p style="text-align: center; font-weight: bold;">Physical Distancing</p> <div style="text-align: center;">  </div> <p>Physical distancing means maintaining a physical distance of 3 feet or greater between yourself and others whenever possible.</p>

List COVID-19 symptoms, preventative measures (including staying home when sick), and good hygiene.</li> <li>• Clean/disinfect frequently touched surfaces at least daily and shared objects after each use.</li> <li>• Face masks/coverings are recommended, but are optional for learners and staff. 	<p><b>APEX</b></p> <ul style="list-style-type: none"> <li>The district will utilize the <a href="#">Apex Learning platform</a> for alternate instruction and curriculum (1 class at a time, core curriculum, limited electives).</li> <li>Learners who choose this option are required to remain in the online program for the entirety of the trimester in which they are enrolled during the 2021-2022 school year.</li> <li>This option is available to learners in grades 10 – 12 by application only.</li> <li>Space is limited. The registration deadline is <b>August 11, 2021</b> for the first trimester. Contact your learner’s high school for registration information.</li> <li>Standard grading will be applied, must pass course with a 70% or better.</li> <li>Learners must pass 4-5 classes per trimester to stay on track for graduation. Each course should take 2-3 weeks to complete.</li> <li>Parental involvement is a key factor to learner success. Learners should expect to spend a minimum of 4 hours daily working online.</li> </ul>

Such strategies include the following:</p> <p><b>Learners</b></p> <ul style="list-style-type: none"> <li>School counselors are assigned to all schools including one at each elementary, two at each of the middle schools and three at each of the high schools. Additionally, the alternate middle/high school has one counselor and one social worker.</li> <li>The district partners with Health West, Inc. to offer additional counseling to learners in need of additional mental health support.</li> <li>Community Resource Workers (CRWs) are available across the district to address a variety of health issues. They have access to multiple community resources to support nutrition, social, emotional and mental health concerns for all learners.</li> <li>Utilize newly purchased health curriculum with a greater emphasis on social, emotional and mental wellbeing.</li> <li>Utilize Second Step curriculum K-8 to address social, emotional and mental wellbeing.</li> <li>School counseling portals are available online 24/7 with mental health resources including 24/7 crisis and suicide hotline information.</li> <li>All teachers participated in professional development for trauma informed teaching practices and resiliency provided by Keith Orchard.</li> <li>All teachers annually complete suicide awareness training.</li> </ul> <p><b>Staff</b></p> <ul style="list-style-type: none"> <li>Expand the district’s Wellbeing Rewards Program to provide staff with additional opportunities to participate in activities which focus on the five dimensions of wellbeing.</li> <li>District Wellness Ambassadors will continue to promote the importance of preventative care measures including annual wellness exams, biometric screenings, flu shots, dental cleanings and additional age appropriate screenings such as mammography and colonoscopy.</li> <li>Create a program designed to provide employee choice in compliance with the Affordable Care Act (ACA), Americans with Disabilities Act (ADA) and Genetic Information Nondiscrimination Act (GINA).</li> </ul>

<p><b>When a Staff Member, Learner or Visitor Exhibit Symptoms at School</b></p>	<ul style="list-style-type: none"> <li>• Work with school administrators, school nurses, and other healthcare providers to identify an isolation room or area to separate anyone who exhibits COVID-like symptoms.</li> <li>• Follow <a href="#">Standard and Transmission-Based Precautions</a> when caring for symptomatic individuals.</li> <li>• Follow procedures for arranging transportation for anyone who is symptomatic to their home, or to a healthcare facility.</li> <li>• Notify local health officials, staff, and families immediately of a confirmed case while maintaining confidentiality consistent with applicable federal and state privacy laws.</li> <li>• Close off areas used by a symptomatic individual and do not use before cleaning and disinfection. Ensure safe and correct application of disinfectants and keep disinfectant products away from children.</li> <li>• Advise symptomatic staff members and learners not to return until they have met state and local health department criteria to discontinue home isolation. COVID related absences may be excused on a case-by-case basis with an opportunity for informal and/or formal review.</li> <li>• Inform those who have had close contact to a person diagnosed with COVID-19 to follow state and local health official guidance.</li> <li>• Follow appropriate state and local health official guidance for home quarantine.</li> </ul> <p><b>WHAT IF AN INDIVIDUAL EXPERIENCES SYMPTOMS OF COVID-19?</b></p> <ul style="list-style-type: none"> <li>• Stay home if sick.</li> <li>• Practice physical distancing.</li> <li>• Practice good hand hygiene.</li> <li>• Cover cough and sneezes.</li> <li>• Wear cloth face coverings in public places.</li> <li>• Disinfect surfaces and objects regularly.</li> <li>• Avoid touching your eyes, nose, and mouth with unwashed hands.</li> </ul> <p><b>YOU MAY DISCONTINUE SELF-ISOLATION:</b></p> <ul style="list-style-type: none"> <li>• At least 24-hours have passed since recovery defined as resolution of fever without the use of fever-reducing medications; and</li> <li>• Improvement in respiratory symptoms (e.g., cough, shortness of breath); and</li> <li>• At least 10 days have passed since symptoms first appeared OR if asymptomatic at least 10 days after positive test result.</li> </ul>

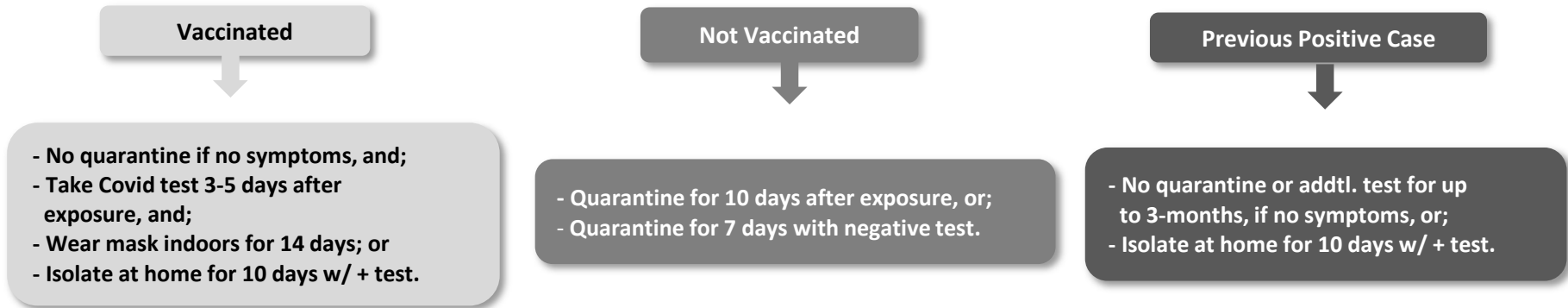

## A member of my household has been identified as a close contact of a confirmed case of COVID-19. What's next?

**Who Needs To Quarantine?** If you or your child is identified as a known close contact of a confirmed COVID 19-case, please refer to the following recommendations, which are subject to change in accordance with new information provided by the CDC. If you have specific questions about your child or your family as it relates to a positive case of COVID-19, please contact the Southeastern Idaho Public Health Department at 208-233-9080.

Please note, these are **recommendations** families are asked to consider following:



Quarantine is used to keep someone *who might have been exposed to COVID-19* away from others. Quarantine also helps prevent the spread of disease that can occur before a person knows they are sick or if they are infected with the virus without feeling symptoms. Individuals in quarantine should stay home, separate themselves from others, monitor their health, and follow directions from the state or the local health department.

**Please monitor for symptoms:** People with COVID-19 have had a wide range of symptoms reported, ranging from mild symptoms to severe illness. Symptoms may appear **2-14 days after exposure to the virus**. People with one or more these symptoms may have COVID-19:

- Fever or chills
- Cough
- Headache
- Fatigue
- Muscle or body aches
- Sore throat
- Diarrhea
- Congestion/runny nose
- Shortness of breath or difficulty breathing
- Nausea or vomiting
- New loss of taste or smell

**\* Families are expected to self-manage any quarantine(s) in consultation with the Southeastern Idaho Public Health Department.**

**FAQ: I suspect that my child is a close contact of a confirmed case of COVID-19. Why haven't I received notification?** Notifications are sent to families for those individuals that the Southeastern Idaho Public Health has provided documentation to PCSD 25 as having been identified as a known close contact of a confirmed case of COVID-19. If you are concerned about the risk of exposure, PCSD 25 encourages the wearing of masks/face coverings indoors.
